USCIS added a new \$600 "Asylum Program Fee" to be paid by all petitioners, except small employers who will pay \$300 "Asylum Program Fee" while filing Form I-129 nonimmigrant petitions and Form I-140 immigrant visa petitions. There is no "Asylum Program Fee" for IRC  $\S 501(c)(3)$  nonprofit petitioners.
- ii. I-131 and I-765 filing fees now must be paid even when filed in connection with and/or concurrently with an I-485 adjustment of status application
